Recommendation: Recommend acceptance of bids as noted on attached bid tabulation sheet as lowest and best responsive, responsible bids meeting written specifications.

Term of Contract This bid is the annual new, and replacement, athletic uniforms for use throughout the District. Prices are firm and fixed for the items specified; however, additional options and extras (logos, striping, etc.) may be purchased either at a discount from manufacturer's list price or at a net price. Quantities in bid are anticipated requirements and are contingent upon availability of school funds.

Notations and Exceptions: Recommend disqualification of Bob's Athletics for items 106A, B & C due to inability to attend mandatory meeting on March 15, 2006 at Land O' Lakes High School to place uniform orders with school athletic directors. Recommend acceptance of next low vendor.

AU506A and 5096B: Recommend rejection of these items for failure to receive any bids. Request permission to purchase on the open market after receiving written quotes.

Although we received only one bid for some items, the bid is deemed competitive based upon past bid pricing structures.

Offers from the vendors listed herein are the only offers received timely as of the above opening date and time. All other offers submitted in response to this solicitation, if any, are hereby rejected as late.
