Recommendation: Recommend acceptance of bid as noted on the attached tabulation sheet as lowest and best bid meeting written specifications.

Term of Contract: This is a one-time purchase for paper products to be stocked in the central warehouse for use throughout the District.

Notations and Exceptions: In most cases, paper was bid in two groups per category (i.e., Group I Drawing Paper – Non-Recycled) and Group I-A Drawing paper – Recycled content. Any group denoted with an “A” after the group refers to a recycled content product. Bidders were advised only one group would be awarded based upon costs. Where recycled products are recommended for award, recycled bids were within the 10% price variance (price preference), met minimum specified recycled content, provided required samples, and were lower in price than the non-recycled products being bid.

Savings were based upon the total average price for each category (i.e., Group I Drawing Paper – Non-Recycled). One No Bid was received from Dick Blick Art Materials.

Offers from the vendors listed herein are the only offers received timely as of the above opening date and time. All other offers submitted in response to this solicitation, if any, are hereby rejected as late.

Notes and Exceptions

Group I and IA (Drawing Paper): Still being evaluated – will forward to a later Board meeting.

Group II and IIA (Xerographic Paper): Reject – Request permission to order from State Contract #645-120-04-1 with Mac Paper in the amount of \$372,169.60 for recycled as pricing is considerably less than bids received. Low bid from Peninsular Paper could not guarantee price for split shipments.

Group IV and IVA (Practice Paper): Still being evaluated – will forward to a later Board meeting.

Group V and VA (Construction Paper): Still being evaluated - will forwarded to a later Board meeting.

Group VI and VIA (Railroad Board): Still being evaluated - will forwarded to a later Board meeting.

Group IX – File Folders, Manilla: Recommend bid from Pyramid School Products as lowest and best bid meeting written specifications and testing criteria. Low bid from Windtree Enterprises did not send samples for testing purposes as specified in bid documents and therefore could not be considered.

Group X (Office Pads): Still being evaluated - will be forwarded to a later Board meeting.

Group XII, Item JS-20 and JS-20A (Single-fold Towels): Reject – request permission to purchase from State Contract #640-002-06-1 from Dade Paper Company at \$11.45 a case for a total of \$49,464.

Group XII, Item JS-21 and JS-21A (Multifold Towels): Reject – request permission to purchase from State Contract #640-002-06-1 from Dade Paper Company at \$11.45 a case for a total of \$49,464.

Group XV (Art Tissue Paper Assorted Colors): Still being evaluated – will forward to a later Board meeting.

Group XVI (File Folders Assorted Colors): Recommend acceptance of bid from AFP Industries as lowest and best bid meeting written specifications and testing criteria.

Group XVII (File Folders Assorted Colors): Recommend award to Group XVI. Low bid from Quill Corporation did not send samples for testing purposes as specified in bid documents and therefore could not be considered.
