MEMORANDUM

RE: Bid #04-097-PC Commodity Food Processing
Third Year of Three-Year Contract

On April 4, 2004, official action (attached) was taken to award the above mentioned bid to various vendors. This bid is a three-year contract, renewable annually based upon mutual consent of all parties.

The vendors awarded this bid are: Conagra Foods, East Side Entrees, Gold Kist, JTM Provisions Co., Inc., Jeannie-O-Turkey Store, Land O'Lakes, Inc., J. M. Smucker Company, M & B Produce, Inc., Michael Foods, Pierre Foods, Inc., Rich-Seapak Corp., Schreiber Foods, Inc., Sunny Fresh Foods, and Tyson Foods. Eleven of the fourteen vendors have agreed to extend the terms and conditions of this bid.

East Side Entrees, Gold Kist, JTM Provisions Co., Inc., Jeannie-O-Turkey Store, Land O'Lakes, Inc., J. M. Smucker Company, M & B Produce, Inc., Michael Foods, Pierre Foods, Inc., Rich-Seapak Corp., and Tyson Foods have agreed to extend the terms and conditions of this bid. However, Conagra Foods, Schreiber Foods, Inc., and Sunny Fresh Foods did not agree to extend the terms and conditions of this bid due to price increases. The agreements will expire on June 30, 2006.

East Side Entrees, Gold Kist, JTM Provisions Co., Inc., Jeannie-O-Turkey Store, Land O'Lakes, Inc., J. M. Smucker Company, M & B Produce, Inc., Michael Foods, Pierre Foods, Inc., Rich-Seapak Corp., and Tyson Foods have agreed to renew the same prices as original bid award. Three vendors, Jeannie-O-Turkey Store and Land O'Lakes, Inc., and Smuckers, would like to renew with a price increase based upon Producer Price Index-Commodities, Series ID WPUSOP3110, Not Seasonally Adjusted, and/or Producer Price Index Revision-Current Series (Motor Freight transportation and Warehousing), Series ID PCU42#(N) as allowed in the bid terms and conditions. The annual percentage change in the Producer Price Index is based on the January 2005 index for the third contract year. Both vendors are within the Producer Pricing Index as permitted in the terms and conditions of the bid.
