Recommendation: Recommend acceptance of bid from Woodside's Photography as best bid meeting written specifications and evaluation criteria.

Term of Contract: This is the first year of a three-year contract, renewable annually by mutual agreement of all parties for school pictures to be utilized by Hudson High School and Zephyrhills High School as noted on the attached list. The first year of the contract will commence on August 17, 2005 and expire on August 16, 2006.

Notations and Exceptions: Bids were awarded on a weighted point system: Price (10 pts.); Commission (5 pts.); Location (2 pts.); and References (3 pts.). The commission (revenue) to be received by the schools will all be the same whereas in the past the commission varied from school to school. The commission will remain firm and in effect throughout the contract period; however, package prices may increase annually based upon the Consumer Price Index for urban wage earners and clerical workers, U.S. city average, Table 3, all items index, published by the U.S. Bureau of Labor Statistics.
