After receipt of our purchase order, W. B. Hunt notified the District that they were unable to deliver these products at their bid price. Additionally, in dealings with recent school District staff W. B. Hunt has communicated in a curt and inappropriate manner. Therefore W. B. Hunt has been removed from doing business with the District for a period of 3 years.

Recommend acceptance of bid from So. Business Communications for IT-02A and IT-03A, Smiley's Audio Visual, Inc. IT-02B and Crest A/V Electronics IT-25 as best bids meeting written specifications and criteria.
