**Recommendation:**

Recommend acceptance of bids as noted on attached bid tabulation sheet as lowest and best responsive, responsible bids meeting written specifications.

**Term of Contract:**

This bid is for the annual new and replacement athletic equipment for warehouse delivery and distribution throughout the District. Quantities in the bid are anticipated requirements and are contingent upon availability of school funds.

**Notations and Exceptions:**

Recommend rejection of bids from Riddell All American and Bill Fritz for failure to return the entire bid as required in the bid document.

Items AE-202, 212 and 223: Awarded "All or None" to the same manufacturer as specified in the bid documents.

Items AE-402, AE-458, AE-459, AE-463, AE-464, AE-465, AE-466, AE-470, AE-471, AE-484, AE-618, AE-633 and AE-640: Recommend rejection of these items for failure to receive any bids. Request permission to purchase on the open market after obtaining written quotes.

Items: AE-422, AE-434, AE-438, AE-445, AE-446, AE-449, AE-451, AE-474, AE-477: Recommend rejection of these items because prices are higher than anticipated, and it is in the best interest of the District to obtain quotes. Request permission to purchase on the open market after obtaining written quotes.

Although we received only one bid for some items, the bids are deemed competitive based upon past bid pricing structures.

Savings were based on a quantity of one of each item deducted from average of other bids submitted. Quantities for items will not be available until the meeting with the Athletic Directors in March.
