

Floor Installation Service, Inc. (Renewal)

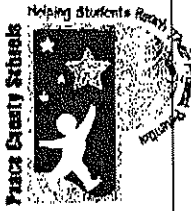
