**ARTICULATION AGREEMENT  
BETWEEN  
DISTRICT SCHOOL BOARD OF PASCO COUNTY

PASCO-HERNANDO COMMUNITY COLLEGE**

This document defines the Health Science Core Courses Articulation Agreement between the District School Board of Pasco County (DSBPC) and Pasco-Hernando Community College (PHCC). DSBPC students who qualify under this agreement will receive credit for those courses if they enroll in the Dental Assisting Technical Certificate (TC), Emergency Medical Services (A.S.) Degree, Emergency Medical Technician Applied Technology Diploma (ATD), Health Unit Coordinator Technical Certificate (TC), Medical Administrative Specialist Technical Certificate (TC), Medical Coder/Biller Applied Technology Diploma (ATD), and/or the Medical Record Transcribing Applied Technology Diploma (ATD) at PHCC.

Stipulations of the Agreement:

Students are required to:

- Complete the Health Science Core courses with a minimum grade point average of 3.0 and an overall high school grade point average of 2.5.
- Complete the PHCC application process for admission.
- Submit an official District School Board of Pasco County high school transcript to the PHCC Admissions and Student Records Office.





This document defines the conditions of the Industrial Management Technology Associate in Science Degree Articulation Agreement between the District School Board of Pasco County (DSBPC) and Pasco-Hernando Community College (PHCC). DSBPC students who qualify under the conditions of this agreement will be awarded credit toward the technical training requirement in the Industrial Management Technology Associate in Science degree at PHCC.

Stipulations of the Agreement:

Prior to the award of credit students must successfully complete 15 credits in the Industrial Management Technology program. Students should contact the PHCC Admissions and Student Records Office upon completion of the 15 credits.

Students are required to:

- Complete the postsecondary adult vocational program with a grade of "C" or better in each course.
- Complete the PHCC application process for admission.
- Submit an official Moore-Mickens Education Center transcript to the PHCC Admissions and Student Records Office.




