SUBJECT: Renewal of Florida Department of Education, Division of Vocational Rehabilitation

On August 17, 2010, official action (attached) was taken to approve the above-referenced contract for community-based work experiences. The term of the contract is due to expire on June 30, 2011. 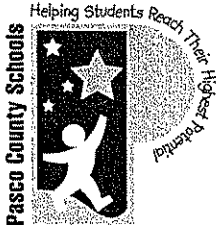
