The purchase orders to NCS Pearson, Inc. have reached the threshold that requires Board approval. Therefore, I am attaching the current purchase orders referenced above for the Board's review and approval.

Under the Department of Education Rule 6A-1.012(11)(b), the requesting of bids from three (3) or more sources is waived for the purchase of educational services and any type of copyrighted materials including, without limitation, educational tests, printed instructional materials, computer software, etc., where such items are purchased directly from the manufacturer, producer, publisher, the owner of the copyright, an exclusive agent within the state, a governmental agency or a recognized educational institution. Considering NCS Pearson, Inc., holds the copyrights (see attached), it is my recommendation that the Board approve the attached purchase orders to NCS Pearson, Inc. for \$75,249.

In addition to the \$75,249 requested, we are requesting an additional \$25,000 to cover future orders through June 30, 2011.
