Recommendation:

Recommend acceptance of the bid from Fruhauf as noted on the attached tabulation sheet as the lowest and best bid meeting written specifications and testing criteria.

Term of Contract:

This is a one-time purchase. Prices to remain firm for 90 days after receipt of uniforms.

Notations and Exceptions:

This bid is for marching band uniforms to be utilized by Fivay High School and is part of the start-up band program at Fivay High School. Band uniforms are part of a rotational uniform program for the District and are replaced approximately every seven years.

Recommend rejection of lower priced bid from DeMoulin. Seam allowances were not wide enough to allow repair of frayed fabric, snaps for hemming were visible from the outside of the pant legs, and coat cuff ripped when slight pressure was applied. Recommend rejection of lower priced bid from Ictus. Pant leg seams unfinished and puckered when stretched, coat top is bulky, sash (color strip) buckles when jacket is fastened, pant fabric is very thin, and plume feathers sag.
