**Notations and Exceptions:**

Recommend rejection of bid from Cross Construction Services, Inc. because of failure to properly execute (original signature) the last page of RFP document as specified.

The evaluation consisted of a selection review committee, made up of representatives from the Maintenance and Facility Operations Department.
