Beginning in the 2009-2010 school year, in accordance with Florida Statute 1002.415 and Senate Bill 1676, the District has provided eligible K-12 students the option of participating in a virtual instruction program.


Two of the numerous organizations providing on-line services to the District are Accelerate Education /eDynamic and Florida Virtual School /FLVS Franchise. In order to simplify the online and distance learning technology process, JoAnne Glenn, Assistant Principal for Pasco eSchool, is requesting to include virtual courses now provided by Accelerate Education /eDynamic to be provided by Florida Virtual School /FLVS Franchise. Please reference the attached memo from Ms. Glenn for additional information.

We are now requesting the Board sign the attached addendum retroactively. Notice of this change was given in late December 2011 and it was necessary to have the courses available at the beginning of the first semester of 2012. Nancy Alfonso, Board Attorney, has reviewed and approved the Addendum and has approved submitting it to the Board retroactively.

The annual cost for this vendor is projected to be \$150,000.00 and will be funded by the FTE from the student's successful credit completion per half credit. If you have any questions or concerns please notify Ms. Glenn or myself at your earliest convenience.

Subject: Addendum to Contract for School District Virtual Instruction Program (Florida Virtual School/FLVS Franchise)

In accordance with Florida Statute 1002.415, 1002.37 and Senate Bill 1676, beginning with the 2009-2010 school year, each school district shall provide eligible K-12 students within its boundaries the option of participating in a virtual instruction program. The program makes instruction available to students using online and distance learning technology in the nontraditional classroom.

To provide the students with a variety of learning opportunities and to support our schools as they work to comply with class-size requirement, Pasco eSchool requests approval for the enclosed contract addendum to include new virtual courses recently released by the following provider:

- The Florida Virtual School - FLVS

The cost, as outlined in the contract by the provider, is determined by the number of student enrollments and by the course selection. Generally, most courses carry a fee of \$50 per student, per semester. The courses outlined in this addendum have different fees as they are licensed from third party curriculum developers, and the additional fees reflect those costs.

The annual cost of the fees paid to this vendor is projected to be \$150,000. The program will be funded through FTE earned by students enrolled in grades 6-12 by successful credit completion per half credit.
