We have been requested by the Maintenance Department to seek permission to "piggy-back" the Broward County School Board bid for bleacher repair services.

Under DOE Rule 6A-1.012(5), the Board may make purchases at the unit prices in contracts awarded by other governmental agencies. Considering a competitive process was conducted through the School Board of Broward County that resulted in an award for bleacher repair service and a vendor who was awarded under this contract, Lyle Bleachers, Inc. is willing to extend the same terms and conditions of this bid to our District, it is my recommendation to "piggy-back" the School Board of Broward County bid #11-051T.

At this time, we are requesting permission to "piggy-back" the School Board of Broward County's bid and to place purchase orders not to exceed \$100,000 for the period of April 1, 2012 through March 31, 2013 utilizing general funds. The Purchasing Department will monitor and calculate all purchase orders to the above-referenced vendor to verify that the dollar limit is not exceeded.
