Pinellas County School Board Bid # 12-880-103 – Audio Visual Innovations, Inc.

Poster Printer and Poster Printer Standard Paper

The Purchasing Department is requesting approval to "piggy-back" Pinellas County School Board Bid # 12-880-103 – Audio Visual and Video Equipment/Materials for the purchase of Poster Printers and Poster Printer Standard Paper from Audio Visual Innovations, Inc. on an "as needed" basis. The piggyback will allow the District to receive a 5% discount off the manufacturer's price for VariQuest/Varitronics Paper along with a unit price of \$4,995 for the Poster Printer. This contract is effective February 7, 2012 through January 25, 2013.

The estimated total dollar amount of \$50,000 is based upon orders processed by the District for the last fiscal year. The Purchasing Department will monitor transactions to assure the estimated dollar amount is not exceeded.
