Recommendation:

Recommend acceptance of bids as noted on attached bid tabulation sheets as lowest and best responsive, responsible bids meeting written specifications.

Term of Contract:

This bid is the annual new and replacement athletic equipment for use throughout the District. Quantities in bid are anticipated requirements and are contingent upon availability of school funds. The contract term shall be effective from March 6, 2012 through March 5, 2013.

Notations and Exceptions:

Offers from the vendors listed herein are the only offers received timely as of the specified opening date and time. All other offers submitted in response to this solicitation, if any, are hereby rejected as late.

Items: AE-225, AE-400, AE-419, AE-421, AE-460, AE-461, and AE-981: Recommend acceptance of bid from Allen Sports Center. Although only one (1) bid was received from Allen Sports Center, it has been determined that the prices are competitive based on catalog pricing comparisons and last year's awarded bids from Allen Sports Center.

Items: AE-402, AE-458, AE-459, AE-463, AE-464, AE-470, and AE-471: Recommend acceptance of bid from Riddell/All American. Although only one (1) bid was received from Riddell/All American, it has been determined that the prices are competitive based on catalog pricing comparisons and last year's awarded bids from Riddell/All American.

Notations and Exceptions:

Items: AE-203 and AE-980: Recommend acceptance of bid from Allen Sports Center. Although only one (1) bid was received from Allen Sports Center, it has been determined that the prices are competitive based on catalog pricing comparisons and last year's award for this item.

Items: AE-231, AE-232, AE-485, AE-730, and AE-731: Recommend acceptance of bid from Allen Sports Center. Although only one (1) bid received, pricing is deemed competitive, based on two (2) retail price comparisons. Note: Items were not included on last year's bid.

Item: AE-484: Recommend acceptance of bid from Riddell/All American. Although only one (1) bid received, pricing is deemed competitive, based on two (2) retail price comparisons. Note: Item was not included on last year's bid.

Items: AE-465 and AE-466: Recommend acceptance of bid from Gilman Gear. Although only one (1) bid was received from Gilman Gear, it has been determined that the prices are competitive based on catalog pricing comparisons and last year's award for this item.

Item: AE-931: Recommend acceptance of bid from BSN Sports. Although only (1) bid was received from BSN Sports, it has been determined that the price is competitive based on catalog pricing comparison and last year's award for this item.

Items: AE-640, AE-701, and AE-725: Recommend rejection of these items as bids received from MFAC, LLC. and Allen Sports Center have been determined to not be cost-effective for the District. Requesting permission to purchase on the open market after receiving competitive prices.

Bid from Keesey Company was disqualified as vendor failed to both execute and include last page (signature) of their bid document.

Savings were based on an estimated quantity of each item deducted from average of other bids submitted. Quantities for items will not be available until the meeting with the Athletic Directors in March and as needed throughout the school year.


