U.S. Foodservice

Per DOE Rule 6A-1.012(4) the District is permitted to tag-on to bids from other governmental entities, should it choose to do so. In an effort to obtain the best pricing structure for Mainline Foods, 24 school districts in Florida (including ours) worked together to form a cooperative bid for buying mainline foods. Martin County was the lead agency for this process. The bid is a five-year contract, with three subsequent one-year renewals, pending mutual agreement of the parties. In addition, the bid calls for six-month reviews of new products and pricing. The District has been utilizing Martin County School Board's RFP # 5001-0-2006/JF: Mainline Foods for six years. We are requesting to continue to utilize Martin County School Board's RFP # 5001-0-2006/JF: Mainline Foods which has been extended for the second year and covers the contract period from July 1, 2012 through June 30, 2013.

Ed Hart, Regional Business Development Manager, U.S. Foodservice, has agreed to extend the terms and conditions of RFP # 5001-0-2006/JF: Mainline Foods to our District - see attached.

It is anticipated that our District's expenditures for these products would be approximately \$9,000,000 using Special Revenue Funds.
