Revised Revenue Sharing Schedule

On July 11, 2011, official action was taken to allow the District to "piggy-back" the Volusia County School Board RFP S-877LR for Procurement Card Services for the third year. The contract term is September 27, 2011 through September 26, 2012.

The District was notified (see attached) that starting on January 1, 2012, based on our year-to-date spend Regions Bank will increase our Purchasing Card Rebate from 1.31% to 1.40% which will earn the District an additional \$17,000. Last year the District earned an estimated \$65,000 with this rebate. The revenue sharing schedule is allowable under the Volusia County School Board RFP and the Purchasing Department has verified this adjustment has been approved by their District.

Under DOE Rule 6A-1.012(6), the Board may make purchases at or below the specified prices from contracts awarded by other governmental agencies. Therefore, it is my recommendation to enter into this revised revenue sharing schedule with Regions Bank. If you have any questions, please feel free to contact me at your earliest convenience.
