SUBJECT: Renew Annual Contract for Medical Claims Overpayment and Recovery Service
MicroVu, LLC

As you know, the District has self-insured its medical program with Blue Cross/Blue Shield since January 1, 2009. An important part of the self-insurance process is to have an audit performed on the medical claims to assure that claims are being processed accurately. On July 6, 2010, official action (attached) was taken to approve a contract with MicroVu, LLC for these services.

Please see the attached detailed memo from Ms. Mary Tillman, Director of Employee Benefits, Assistance and Risk Management (EBARM). She is requesting that the Board approve renewal of the contract (on file in Purchasing) for its next term, May 11, 2012 – May 10, 2013. Per Florida Administrative Rule 6A-1.012(11)(a), the District is permitted to negotiate for auditing services of this nature. MicroVu will be paid a portion of the monies recovered on a contingency basis, so there is no out-of-pocket cost to the District for this contract.

We request Board approval of this annual renewal, allowing EBARM to continue the process of auditing claims dating back to the beginning of our self-insured program. Please feel free to contact Mary Tillman or me if you have any questions or concerns.

RE: MicroVu – Overpayment and Recovery Service

An important part of the process of being self-insured for the medical program is to have an audit done of the medical claims to assure that claims are processed accurately. With assistance from Al Waters, the District's consultant, we reviewed several options for claim auditing.

Options include traditional audits that include reviewing a sample of the claims or an electronic review of all claims. After careful review of all options, we decided to engage MicroVu for medical claims auditing services.

MicroVu is a recovery firm, which performs reviews of paid medical claims, recovering and refunding the overpayments to self-funded employer health plans. The overpayment recovery services reviews 100% paid claims, reviewing, recovering and refunding overpayment to the Plan. Leading causes of overpayments are improperly applied DRG of Case Rates, duplicate payments, and Coordination of Benefit errors. MicroVu specializes in the review and recovery of Medicare related overpayments for retiree plans. MicroVu estimates that the District will recover a least 1.8% of the total medical spend, which is approximately \$684,000.

MicroVu is paid a portion of the recoveries as described in the Agreement, so there are no out-of-pocket costs to the District.

Please ask the Board to renew this contract so that MicroVu can continue the process of auditing claims dating back to our initial self-insured date of January 1, 2009.

As always, I appreciate your assistance and that of your staff during this process.
