RE: Bid #12-020-DR: Milk and Milk Products
Southeast Milk, Incorporated (SMI) Increase
Clover Creek Foods, Incorporated

On July 5, 2011, official action was taken to award the above-referenced bid to Clover Creek Foods, Incorporated.

Based on the bid document, if a Federal milk marketing order increases or decreases the price of raw milk of \$0.08 per hundred weight, thereby increasing or decreasing the cost of milk \$0.00054 per half pint, the School Board shall adjust the price paid to the milk contractor to conform to the increase or decrease as aforesaid. Any change in prices must be accompanied by an appropriate copy of the USDA, Agriculture Marketing Service (AMS), Dairy Programs Announcement of class prices and the Southeast Milk, Incorporated (SMI), price announcement or other pre-approved price change announcement. The premium from SMI/DFA increased from \$4.52 to \$4.60 per CWT effective April 1, 2012 (see attachments). The premium from SMI/DFA is an allowable charge and is integrated into our ½ pint milk calculation.

Rick Kurtz, Director of Food and Nutrition, is requesting permission for the price increase be retroactive as of April 1, 2012, which is allowable as per bid document.
