SUBJECT: Renewal of Contract with Bright House Networks, LLC

On March 1, 2011, official action was taken (attached) to enter into a contract with Bright House Networks, LLC (Bright House) for telecasting of all regular season, postseason, and All-Star games and sporting events in which the District School Board of Pasco County high schools may participate. This is a multi- year agreement renewed annually by mutual agreement. The complete contract is available in the Purchasing Department for review. The current term will expire on June 30, 2012.

As services have been satisfactory, Mr. Paul Kosuth, General Manager Bright House Sports Network, was contacted and agreed to extend the current terms and conditions of the contract (attached). The new term will be for the 2012- 2013 school- year. As per the terms of this agreement Bright House will pay the District on or about September 1, 2012, \$19,000. In addition Bright House will pay \$500 per game to the home school for each game that is telecast.
