**SUBJECT:** Renewal of Contract with Carone Fitness, Inc.

The program makes instruction available to students using online and distance learning technology in the nontraditional classroom. Carone Fitness, Inc. (Carone) is one of the virtual instruction programs the District is currently using to comply with this requirement.
