On August 16, 2011, official action (attached) was taken to enter into the first year of Bid 12-028-DR with USI-IDS. The first year of the contract term is September 7, 2011 through September 6, 2012. This recommendation was for an anticipated \$108,000 spend for the first year.

Vending Machine Equipment Bid #12-028-DR

The Food and Nutrition Services Healthy Vending program generated approximately \$320,000.00 in revenues for the fiscal year ended June 30, 2012. In our Self-Service vending machine equipment bid #12-028-DR we stated that in year one (2012-2013) we anticipated purchasing ten (10) refrigerated and forty (40) non-refrigerated vending machines. In year one, \$73,110.00 has been spent to date. Increasing to \$200,000.00 will allow another \$126,890.00 to be spent before expiration. The information submitted to the Board reflected estimated purchases of \$108,000.00 in year one.

The District currently has an adult, full-service snack vending program. This contract will not be renewed for the 2012-2013 school year. As a result, FNS is expanding their Healthy Vending program to the adult areas in thirty-five (35) schools to start the 2012-2013 school year and additional schools as deemed viable through-out the 2012-2013 school year. In order to have the initial thirty-five (35) vending machines (25 non-refrigerated and 10 refrigerated) installed by August 13, 2012, we need to amend the estimated dollar value of year one purchases from the \$108,000.00 to \$200,000.00.

FNS will continue to analyze the economic viability of expanding our Healthy Vending program. We estimate that an additional seventy (70) vending machines may be purchased during the 2012-2013 school year for our adult vending program (approximately \$300,000.00). Also, FNS is continuing to monitor our exclusive beverage contract with Coca-Cola. Should their service not meet our contractual expectations, FNS would replace the approximate 155 Coca-Cola student beverage vending machines with approximately 130 FNS beverage machines.
