On October 19, 2010, official action was taken to approve a one-year "piggyback" agreement with GameTime, Inc. utilizing US Communities; RFP#269-2010-183/ Contract# 110179 to purchase playground equipment. In lieu of requesting competitive solicitations, under DOE rule 6A-1.012(6) the District is permitted to "piggyback" contracts awarded by other governmental agencies. We are requesting permission to enter another one-year agreement utilizing the US Communities RFP#269-2010-183/ Contract# 110179 for the period of July 3, 2012- July 2, 2013.

This agreement was approved originally by Nancy Alfonso, Board Attorney, on September 16, 2010 and the Addendum dated February 1, 2012 was approved by Ms. Alfonso on June 18, 2012. Mr. Rob Dominica, Vice President, GameTime, Inc. has agreed in writing (attached) to extend the terms and conditions of this agreement to the District. The District's immediate needs include five (5) playgrounds for various elementary schools at a total cost of \$200,000. We are requesting an additional \$100,000 to meet the anticipated needs through the 2012-2013 school year. The Purchasing Department will monitor the purchase orders so that they do not exceed the anticipated blanket amount of \$300,000.
