RE: Negotiated Contract – Full Maintenance Coverage for Fire Alarm Systems
SimplexGrinnell

On July 24, 2007, official action was taken to award the above-mentioned negotiated contract to SimplexGrinnell for the full service maintenance and annual inspections of fire alarms throughout the district. This contract will expire on July 30, 2012.

Currently under the Department of Education Rule 6.A-1.012, the Board is permitted to enter into direct negotiations for high technology hardware, software and components when it is in their best interest to do so.

The Purchasing Department is requesting the approval to extend the above-mentioned agreement with SimplexGrinnell for another year. This is a five-year contract renewable annually with permission to extend for one additional year as stated in the original document. James Hampton, District General Manager, SimplexGrinnell has expressed his willingness to extend with the same terms and conditions as the original contract (attached).

At this time, we respectfully request your approval to extend the above-mentioned negotiated contract with SimplexGrinnell. The extension period of this agreement will commence on July 31, 2012 through July 30, 2013.
