On January 19, 2010, official action was taken to award the above-referenced bid JTM Provisions Company for Group B "all or none" line items and renewed for the second year on December 6, 2011 for term dates of July 1, 2012 through June 30, 2013. Current bid language allows new items to be added to the bid by awarded vendors as they become available.

JTM Provisions Company have submitted pricing for two (2) new products using USDA A734 Pork Leg Roasts: (1) Pork Diced, and (2) Cooked Diced Seasoned Pork in Cuban Sauce. Attached you will find the fee for service price information for the new pork products to be effective through June 30, 2013. Adding these items will allow us to better utilize our USDA Entitlement monies. Pricing on these products is at or below retail prices and found to be competitive.

Estimated annual purchases are not anticipated to change the total bid award of \$275,000, Special Revenue Funds. Julie Hedine, Supervisor, Food and Nutritional Services requests these products be added to our USDA Commodity Pork Processing bid.
