Recommendation: Recommend acceptance of bid from USI-IDS per the tabulation sheet as lowest and best responsive, responsible bid meeting written specifications.

Term of Contract: This bid is for the purchase of Vending Machine Equipment for schools throughout the District. This is a three-year bid renewable annually by mutual consent of both parties. The first year of the contract is effective September 7, 2011 through September 6, 2012.

Notations and Exceptions: This bid was awarded as an "all-or-none" for Group 1 to the lowest and best responsive responsible bidder meeting written specifications. Casters and discount off parts was not used as part of the basis for award per the bid specifications. Although only one bid was received, prices have been deemed competitive based on the previously awarded bid submittal along with the Producer Pricing Index (PPI) and Consumer Pricing increases.

Total savings were calculated based on the previously awarded bid along with the Producer Pricing Index and consumer pricing increases.

Offers from the vendors listed herein are the only offers received timely as of the specified opening date and time. All other offers submitted in response to this solicitation, if any, are hereby rejected as late.
