Introduction

Articulation agreements allow qualifying high school students the opportunity to earn college credit for specific Career and Technical Education courses and programs. Currently, articulation agreements between the District School Board of Pasco County and numerous postsecondary educational institutions are providing this opportunity to students.

Description

The Articulation Agreement between the District School Board of Pasco County and The Art Institute of Tampa must be Board approved to enable qualifying high school students the opportunity to earn college credit for specific courses outlined in the attached agreement once they enroll at The Art Institute of Tampa. The agreement saves students and parents time and money as it avoids the duplication of course work successfully completed by students.

Effective upon the date of signing, the Art Institute of Tampa and Marchman Technical Education Center agree to enter into an articulation agreement to benefit Marchman Technical Education Center students who have successfully completed the courses listed below and wish to begin a degree program at The Art Institute of Tampa. Specifically, under this agreement, students may apply for articulated credit from The Art Institute of Tampa for the following courses:

The awarding of credits shall be based upon a completed application from the student and a review/evaluation of the following:

1. The student must graduate from high school and have completed the courses listed above with a grade of "B" or higher.
2. The student must be admitted as a degree-seeking student within 12 months of high school graduation.
3. The student must submit to the Transfer Credit Evaluator a completed Articulated Credit Application including:
 - a) An official Marchman Technical Education Center transcript indicating the grade received in the course(s) listed above as well as the date of graduation.
 - b) A letter of recommendation on school letterhead form the high school teacher and/or counselor confirming the student has achieved the knowledge and skills for the course competencies required.

This Articulation Agreement will become effective upon the signing of the parties listed below and shall remain in effect for 5 years from the date of this agreement or until modified or canceled in writing by either institution. Each party also agrees to notify the other of any changes in their respective curriculum that would necessitate a re-evaluation of the agreement. The Art Institute of Tampa reserves the right to enter into similar agreements with other schools.
