As you know, the School District has Charter School agreements with the following parties:

Academy at the Farm \$15,528.00 Est.
Athenian Academy of Pasco \$11,628.00 Est.
Dayspring Academy \$30,264.00 Est.
Imagine School at Land O' Lakes \$94,524.00 Est.

At the beginning of each fiscal year, purchase orders for the charter schools are forwarded to The Board for payment purposes associated with the charter schools and their Capital Outlay funding. Contracts for the above-mentioned charter schools were previously Board approved on July 29, 2003 (Dayspring Academy; Academy at the Farm), July 25, 2006 (Athenian Academy of Pasco), and July 8, 2008 (Imagine School at Land O' Lakes).

As you may recall, the Capital Outlay unit allocations with these agreements are based upon The State's direction; however, the totals will vary depending upon the actual number of students at each school. At this time, we respectfully request your approval of the above-referenced purchase orders and the estimated dollar amounts for the respective charter schools in order that payments may be made in a timely fashion.
