Books (In-Print, Out-of-Print, Hard Back, Soft Back, etc.) District Wide

Itz Books

On April 5, 2011, we submitted a bid recommendation for Books (In-Print, Out-of-Print, Hard Back, Soft Back, etc.) District Wide to Barnes and Noble with a notation to negotiate with additional interested parties, as we only received one bid. These books are for purchases of supplemental reading materials for curriculum and professional development use. The intent of this direct negotiation was to establish a minimum fixed percentage discount off list prices for book stores with a "local" (Tampa Bay Area) physical retail store and on-line ordering. Local store requirements enable the staff to physically peruse and purchase books, CDs, and audio tapes on an "as needed" basis.

After the Board's approval to negotiate, we contacted three vendors to see if they were willing to negotiate for the Books (In-Print, Out-of-Print, Hard Back, Soft Back, etc.) District Wide. Only Itz Books submitted a Direct Negotiation. As a result of the negotiation, it is our recommendation to award Itz Books as an additional vendor for these books. Itz Books discount off list pricing are: 1-10 Books: 20%; 11-20 Books: 22%, 21+ Books: 25% Discount (see attached).

This will be the first year of a three-year negotiation that is renewable annually by written mutual consent and approval by the Board. The first year of the contract will commence on September 14, 2011 and continue through May 6, 2012. Second year renewal will be from May 7, 2012 through May 6, 2013.

Recommendation: Recommend acceptance of bid from Barnes & Noble, Incorporated, as noted on attached bid tabulation sheet as lowest and best responsive, responsible bid meeting written specifications.

Term of Contract: This bid is for purchasing miscellaneous supplemental Books (In Print, Out-Of-Print, Hard Back, Soft Back, etc.) District wide. These book purchases are not textbooks or library book purchases. They are supplemental reading materials for curriculum or professional development use. This is the first year of a three-year agreement, renewable annually by written consent of both parties. The first year of the contract is effective May 7, 2011, through May 6, 2012.

Notations and Exceptions: Due to the nature of this District's requirements to have multiple vendors available, up to five (5), permission is requested to negotiate with other interested parties. This will allow the variety of books needed by the District. Although only one bid is being recommended, prices are competitive based upon past awarded book bids.

The intent of this bid is to establish a minimum fixed percentage discount off list prices for book stores with a "local" (Tampa Bay Area) physical presence retail store and on-line ordering. Local store requirements enable the staff to physically peruse and purchase books, CD's, and audio tapes on an "as needed" basis.

The following vendors are disqualified as they did not meet bid specifications for having a store location within the Tampa Bay Area: Bound to Stay Bound Books, Incorporated, Encyclopedia Britannica, Children's Plus, Inc., Davidson Titles, Incorporated, Follett Educational Services, Incorporated, Learning Links, Incorporated, Marco Products, Incorporated, Perma-Bound Books, Itz Books, Rosen Publishing Group, Incorporated, and Gareth Stevens Publishing, L.L.L.P.

Total savings were based on past usage.

Offers from the vendors listed herein are the only offers received timely as of the above opening date and time. All others submitted in response to the solicitation, if any, are here by rejected as late.
