

RE: Bid #11-052-GF Grounds Maintenance
Second Year Renewal of a Three-Year Contract
Centennial Middle School – Central Florida Landscaping
Long Leaf Elementary School – A Team Lawn Service, Inc.

On December 7, 2010, official action (attached) was taken to award the above-referenced bid for Centennial Middle School to Ultimate Lawn Care (attached) and Long Leaf Elementary School to A Team Lawn Service, Inc. On July 26, 2011, official action was taken to rescind the bid from Ultimate Lawn Care and re-award to the next low bidder Central Florida Landscaping for Centennial Middle School through the balance of the first year. This bid is a three-year contract, renewable annually based upon mutual consent of the parties. The first year of the agreement will expire on November 21, 2011.

Considering services have been satisfactory, John Reed, Project Manager, Central Florida Landscaping and Rocco C. Ambrogio, Owner, A Team Lawn Care, Inc. were contacted to determine their willingness to enter into the second year of the agreement. As such, they have agreed in writing (attached) to enter into the second year of the agreement.

The second year of the contract will cover the period of November 22, 2011 through November 21, 2012. Bid #11-052-GF Grounds Maintenance – CENMS
For Centennial Middle School

On December 7, 2010, official action was taken to award the above-mentioned bid to Ultimate Lawn Care. After the award, it was brought to our attention that Ultimate Lawn Care has been unable to meet the scheduled service dates and has not been providing satisfactory performance levels.

Although Mr. Charles Williams of Ultimate Lawn Care has been notified by certified mail and has had a meeting with District staff to rectify these performance issues, there has been no progress made with his contracts. Therefore, Mr. Williams was advised his contracts would be terminated effective July 26, 2011. Mr. Williams agreed to finish the month of July's services. However, since that time, Mr. Williams has not performed any of the work. On June 29, 2011 we notified Mr. Williams that his contracts would be terminated effective immediately and he would be assessed the difference in price between his bid and the next low bid.

At this time we are requesting that the Board rescind the award to Ultimate Lawn Care and re-award to Central Florida Landscaping, Inc. for the following school, effective immediately. Central Florida Landscaping, Inc., as next low bidder, has agreed to honor all terms and conditions of their bid.

Rescind: Ultimate Lawn Care - \$ 18,550.00

Re-award: Central Florida Landscaping, Inc. - \$ 22,601.50
