Currently, the Information Services Department purchases Cisco network equipment through a piggy-back of Hillsborough County Bid P-0201-08(JB). This equipment provides local connectivity for services to each school, as well as Internet, e-mail, and TERMS to each workstation within the school. Our current piggy-back term will expire on November 30, 2011.

Under DOE Rule 6A-1.012(6), the Board may make purchases at the unit prices in contracts awarded by other governmental agencies. Presidio Networked Solutions, Inc. (formally Coleman Technologies) has agreed in writing (attached) to extend the terms and conditions of the Hillsborough County bid to the District. Please see the attached memo from Mr. John Simon, Director of Information Services, and Mr. Chris Jackson, Supervisor of Information Services.

We are requesting permission to piggy-back a second year of the Hillsborough County Bid, and to place purchase orders on an as-needed basis not to exceed \$1,000,000.00 for the period December 1, 2011 – November 30, 2012, using budgeted general funds. The Purchasing Department will monitor all Coleman Technologies requisitions to verify that the dollar limits noted above are not exceeded. Request Permission to "Piggy-Back" Hillsborough County Bid P-0201-08(JB)  
for Cisco Network Equipment, Software and Maintenance

Currently, the Information Services Department purchases Cisco network equipment through a piggy-back of Pinellas County's bid #056-0235-B(KC). This equipment provides local connectivity for services to each school, as well as Internet, e-mail, and TERMS to each workstation within the school. The term of this piggy-back will expire on November 30, 2010.

As Pinellas County's contract expires on February 20, 2011, and they will be rebidding the contract, the District cannot continue to piggy-back this bid. We have identified Hillsborough County's above-referenced bid, which is current, and also offers better terms to the District than the previous piggy-back. The awarded vendor is Coleman Technologies. All bid information is on file in the Purchasing Department.

Under DOE Rule 6A-1.012(6), the Board may make purchases at the unit prices in contracts awarded by other governmental agencies. Coleman Technologies has agreed in writing (attached) to extend the terms and conditions of the Hillsborough County bid to the District. Please see the attached memo from Mr. Bruce Baldwin, Director of Information Services, and Mr. Chris Jackson, Supervisor of Information Services.

We are requesting permission to piggy-back the Hillsborough County bid, and to place purchase orders on an as-needed basis not to exceed \$800,000, for the period December 1, 2010 – November 30, 2011, using budgeted general funds.
