

Recommend acceptance of bid from American Visual Display Products, LLC, as noted on attached bid tabulation sheet, as lowest and best, responsive and responsible individual bid meeting written specifications.

Term of Contract:

This bid is for corkboards and markerboards "as needed" by Distribution Services for use throughout the District. This is a three-year bid renewable annually based upon mutual agreement of both parties. The first year of this contract shall be effective from November 2, 2010 to November 1, 2011. The bid prices are firm and fixed for the first year of the contract and may be adjusted annually based on changes in the Producer Price Indexes of # WPU084909, #WPU3012 and #WPU102580162.

Notations and Exceptions:

This bid was solicited on behalf of the Florida Education Purchasing Consortium with the following school districts actively participating: Alachua, DeSoto, Charlotte, Lake, Okaloosa, Pasco, Polk, and Volusia.
