

Recommendation:

Recommend acceptance of bid from Independent Hardware, Inc., as noted on the attached bid tabulation sheet, as lowest and best, responsive and responsible "all-or-none" bid meeting written specifications.

Term of Contract:

This bid is for lever locks "as needed" by the Maintenance Department for use throughout the District. This is a three-year bid renewable annually based upon mutual agreement of both parties. The first year of this contract shall be effective from November 18, 2009 to November 17, 2010.

Notations and Exceptions:

This bid was originally solicited on January 22, 2009, but was put on indefinite hold while testing was performed on the specified manufacturer locks and an additional manufacturer. The test confirmed the additional manufacturer was equal to the specified manufacturers for being greater than Grade 1. Thereafter, the bid specifications were revised and re-solicited on October 2, 2009.

Recommend rejection of Colbert & Cotton, Inc., Fairway Supply, Inc., and Locks Company's bid for failure to return addendum #4 which had significant quantity changes. Clark Security Products had an addition error. This addition error did not change the apparent low bidder.

Offers from the vendors listed herein are the only offers received timely as of the specified opening date and time. All other offers submitted in response to this solicitation, if any, are hereby rejected as late.

Savings were determined by averaging all bids submitted and subtracting the recommended vendor's price.


