

Term of Contract: This bid is for Integrated Pest Management for the School District. This is the first year of a three-year bid renewable annually by mutual consent of both parties. The first year of the contract period is February 3, 2010 through January 19, 2011.

Notations and Exceptions: Weighted criteria was used to determine the lowest and best RFP based on a total of 300 points in the following areas: Licenses and resumes of staff, references, evidence of experience in integrated pest management, insurance requirements, and sample plans for two schools, one elementary and one high school.

Recommend rejection of bid from Bay Area Termite & Pest Control for failure to return cover page and boiler plate as per the bid specifications. Recommend rejection of bids from Haskell Termite, MacCall Services, Prevail Pest Control and Tri-County Pest Control for failure to provide bid deposit as specified in the bid documents.

Recommend acceptance of bid from Cooks Termite & Pest Control with a total points score of 297.
