RE: Request Dollar Approval for Additional Expenditures
Bid # 10-074-DR Playground Mulch – Engineered Wood Fiber Surfacing
Al Robinson Trucking, LLC.

On November 16, 2010, official action was taken to enter into the second year of the above-referenced bid with Al Robinson Trucking, LLC. This recommendation was for an anticipated annual expenditure of \$52,250 for the second year. The second year of the contract covers the period February 11, 2011 through February 17, 2012.

At this time, the Maintenance Department (attached) has determined that an additional \$30,000 will be needed through February 17, 2012, to cover the anticipated expenditures for the balance of the second year. This increase is due to an increased need for playground mulch in order to remain in compliance with ADA safety standards. At this time, it is my recommendation that the Board approve the additional dollar amount of \$30,000 through February 17, 2012.
