Price Decrease Café Favorites

On March 16, 2010, official action was taken to award the above-referenced bid to Café Favorites. It was renewed on November 16, 2010 for the second year for term dates of July 1, 2011 through June 30, 2012.

Café Favorite has indicated that the United States Department of Agriculture (USDA) has changed the pounds of donated food per case on four of the new products recently added to the bid: 1) Deli Flatz-Cold Italian, 2) Sunrise Twist-Turkey Sausage, Egg, American Cheese on a Twist Roll, 3) Sunrise Twist-Egg & American cheese on a Twist Roll, and 4) Sunrise Twist-Turkey Ham, Egg & American Cheese on a Twist Roll. As a result of the USDA changes, Café Favorites has reduced the fee for service and net off invoice pricing to keep the prices per portion at or below our current Board approved prices. Attached you will find the revised pricing information on the four sandwich products to be effective through June 30, 2012. Estimated annual purchases are not anticipated to change the total bid award of \$200,000, Special Revenue Funds.

We received notification from USDA that we need to change our pounds for some of our new products. Because of the pound per case change we have also changed our pricing to reflect lower pricing. You will see that the only pounds per case that were changed are for Turkey and/or Egg, however, for the commodity per case to work out correctly and have a lower price instead of a higher price we changed the cheese only pricing for the majority of our products that we revised. We changed pounds of commodities and pricing on 4 of the new products: Deli Flatz: Italian (#22548), Sunrise Twist-Turkey Sausage, Egg, American Cheese (#50112), Sunrise Twist-Egg & American Cheese (#50140), Sunrise Twist-Turkey Ham, Egg, & American Cheese (#51140)
