

On March 16, 2010, official action was taken to award the above-referenced bid to National Food Group and renewed for the third year on December 6, 2011 for term dates of July 1, 2012 through June 30, 2013.

Current bid language allows new items to be added to the bid by awarded vendors as they become available. National Food Group has submitted pricing for one new product using USDA #100235 (A365) Cherries, Frozen, Cocoa Cherry Bar, Whole Grain 2.2 ounce, 120 portions per case. Attached you will find the fee for service price information for the new fruit product. Adding this item will allow us to better utilize our USDA Entitlement monies. Pricing on this product is at or below retail prices and found to be competitive.

Estimated annual purchases are not anticipated to change the total bid award of \$90,000, Special Revenue Funds. Julie Hedine, Supervisor, Food and Nutritional Services requests these products be added to our USDA Commodity Fruit Processing bid for the remainder of the 2011-2012 school year and the 2012-2013 school year.


