On January 19, 2010, official action was taken to award the above-referenced bid to Cargill Kitchen Solutions and renewed for the third year on December 6, 2011 for term dates of July 1, 2012 through June 30, 2013.

Current bid language allows new items to be added to the bid by awarded vendors as they become available. Cargill Kitchen Solutions has submitted pricing for one new product using USDA #100047 (A566) Eggs. Whole Bulk, Griddle Bakes, IW, 2.6 ounce, 126 portions per case. Attached you will find the fee for service price information for the new egg product. Adding this item will allow us to better utilize our USDA Entitlement monies. Pricing on this product is at or below retail prices and found to be competitive.

Estimated annual purchases are not anticipated to change the total bid award of \$230,000, Special Revenue Funds.
