### MEMORANDUM

SUBJECT: Permission to Place Purchase Order Symantec Antivirus Software through Software House International (SHI)

The District has installed Symantec antivirus software on all District School Board of Pasco County computers. The product has been used for many years, with excellent results. The current contract for the software, purchased through licensed distributor SHI, will expire on February 7, 2013.

The Information Services Department is requesting permission to purchase an upgraded Symantec SymEd Secure Plus Bundle Agreement, for the term February 8, 2013 – February 7, 2014. This program grants the District rights to the management software used to deploy and control the Antivirus Protection Suite. It also includes Home Use Rights for District employees to install Symantec antivirus software on personal home computers at no cost. Please see the attached memo from John Simon, Director of Information Services, and Ed Mutell, Supervisor of Information Services, for further detailed information.

The attached quote from SHI is a multi-year proposal, at a fixed cost of \$85,000 per year. Although we are requesting permission for only one year of the contract, Board approval now will guarantee this fixed price for two (2) additional contract cycles. Requests for these expenditures will be brought to future Board meetings for approval. The District is permitted to negotiate for high-technology purchases of this nature through Florida Administrative Rule 6A-1.012(14).

I am requesting your assistance in obtaining School Board approval for entering into an agreement with Symantec, Inc. This agreement would provide unlimited installation rights for Symantec Antivirus software on all District School Board of Pasco County computers. Included within this SymEd Secure Bundle Plus agreement are the rights to the management software used to deploy and control the Antivirus Protection Suite. An added benefit includes the Home Use Rights for district employees to install Symantec antivirus software on personal home machines at no cost.

The agreement to include these products and installation rights would begin on February 8, 2013 and end on February 7, 2014 for a total cost of \$85,000. The agreement also guarantees that the cost to the district would not increase for the next three years if the Board renewed the agreement for a second and third year.

The funds for this agreement were included in the budget and capital outlay funds would be used for this purchase. The district has been using Symantec Antivirus products for many years with excellent results. With the approval of this agreement, the district will be able to extend antivirus protection to all of its computers at a very aggressive price.
