Term of Contract: This is the first year of a three-year bid, renewable annually, by mutual consent of both parties. The first year of the contract period is April 18, 2012 through April 3, 2013.

Notations and Exceptions: This is a total “all-or-none” bid for the Maintenance Department on an “as needed” basis for termite treatment throughout the District. Grand total is an estimate only, unit prices will prevail.

Recommend rejection of bid from Florida Pest Control & Chemical Company for not submitting the Addendum 1 with their bid, which included new pricing pages. Recommend acceptance of bid from Bingham's Professional Pest Management as lowest and best, responsive and responsible bid meeting written specifications.
