As such, the above referenced vendors have agreed in writing to enter into the second year. However, Christine Sorrell, Office Manager, Anywhere Tours of Florida, has agreed in writing (attached), to enter into the second year of the contract with a price increase of 3.30% based on the Consumer Price Index (CPI) published by the Bureau of Statistics, U.S. Department of Labor, using Series ID: #CUUR0000SETG, Not Seasonally Adjusted as outlined in the bid document using the month of February final version.

At this time, it is my recommendation to enter into the second year of the agreement with the above-referenced vendors. The second year of the contract will cover the period July 1, 2013 through June 30, 2014.

On June 5, 2012, official action was taken to allow the District to directly negotiate with interested parties for Charter Bus Services and award up to four additional vendors. The direct negotiation request was the result of only two responsive, responsible bids received and the District's high demand for these services require a minimum of six vendors.

It is recommended to award the two original submittals from Escot Bus Lines and Martz-First Class Coach Company as the lowest and best bids meeting written specifications.

After the Board's approval to negotiate, Purchasing contacted six vendors interested in contracting for Charter Bus Services. As a result of the negotiations, the District and the vendors highlighted on the attached tabulation sheet have reached a successful agreement.

It is recommended to reject Magical Charters for being non-compliant with the original bid solicitation and non-responsive to the direct negotiation solicitation.

This is a three-year contract, renewable annual by mutual written consent of both parties. The first year of the contract is effective July 25, 2012 through June 30, 2013. The first year anticipated expenditure is \$450,000 using internal and general funds.
