RE: Apple Computer Parts and Consortium Servicing Account Agreement

On June 20, 2006, official action was taken to approve a negotiated contract with Apple for parts for the District's in-house repair and replacement requirements. The contract allows for yearly renewals at the mutual agreement of the parties, and has been renewed every year since its inception. The current term will expire on June 30, 2014.

Considering services have been satisfactory, Mr. John Simon, Director of the Office for Technology and Information Services, and Mr. Craig Coile, Supervisor of the Office for Technology and Information Services, have asked that the contract be approved for the upcoming fiscal year. Please see their attached memo for additional information. Apple has agreed in writing to renew for the upcoming term under existing terms and conditions. The estimated costs for the 2014-2015 school year are \$320,000.

We are requesting Board approval of this contract for the term July 1, 2014 – June 30, 2015. We are also requesting permission for the Office of Technology and Information Services to issue a blanket purchase order not to exceed \$320,000 for this term. Under Florida Administrative Rule 6A-1.012(14), the District is permitted to negotiate for high-technology purchases should it be in our best interest to do so. Purchasing Services will monitor expenditures under this blanket purchase order to ensure that the threshold is not exceeded.
