School Board of Volusia County RFP S-877LR

Regions Bank

On May 7, 2013, official action was taken by the Board to allow the District to continue piggybacking the School Board of Volusia County RFP S-877LR for Procurement Card Services. The contract with Regions Bank is set to expire on June 30, 2014.

Under the Department of Education Rule 6A-1.012(6), the Board is authorized to utilize contracts awarded by other governmental agencies. Regions Bank has agreed in writing (attached) to extend the terms and conditions of the RFP to the District.

With this procurement card program, the District currently has 888 active cardholders and earns a 1.40% rebate back on all spend. Last year the District earned \$99,672.99 with this rebate.

Therefore, it is my recommendation to enter into this piggyback beginning on July 1, 2014 and continuing through December 31, 2014.
