AMENDMENT TO AGREEMENT BETWEEN THE BOARD OF TRUSTEES OF ST. PETERSBURG COLLEGE AND THE DISTRICT SCHOOL BOARD OF PASCO COUNTY

THIS AMENDMENT, made and entered into by an between the Board of Trustees of St. Petersburg College, PO Box 13489, St. Petersburg, Florida 33733-3489, hereinafter referred to as "College," and the District School Board of Pasco County, 7227 Land O'Lakes Boulevard, Florida 34638, hereinafter referred to as "Agency."

WHEREAS, College and Agency entered into that certain Agreement dated December 17, 2013, in which Agency agreed to allow College to use various departments with Agency to conduct laboratory practice and/or clinical experience, hereinafter referred to as the "Agreement"; and

WHEREAS, the Agreement commenced on December 17, 2013, and will terminate on June 30, 2014, unless renewed by College and Agency; and

WHEREAS, College and Agency desire to renew the Agreement for an additional one-year term.

NOW THEREFORE, in consideration of the premises and mutual promises contained in this Amendment and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, College and Agency agree as follows:

- 1. The recitals above are true and correct and are hereby incorporated by reference.
2. The term of the Agreement is hereby extended for one year, from July 1, 2014 through and until June 30, 2015.
3. All other terms and conditions of the Agreement shall remain in full force and effect except as specifically modified herein. If any of the provisions of this Amendment conflict with any terms of the Agreement, the provisions of this Amendment shall govern and control.
