## MEMORANDUM

SUBJECT: New Tool for Reporting Solicitation and Contract Renewals

Historically, the Purchasing Services Department has requested Board approval for yearly **renewals** on multi-year bids, RFPs, RFQs and contracts. These renewals had been presented by individual memo, and often include the extensive paperwork generated by our required due diligence. In an effort to streamline our Board packet, we have developed a spreadsheet (attached) which summarizes the renewal information.

All required documentation from the originating school/department and from the supplier(s) of record is on file in Purchasing Services. We have included contact information for the Purchasing professional who is handling the renewal if you have any questions regarding a particular project. Your approval of the summary spreadsheet will also permit expenditure of the budgeted funds, as needed, which are associated with the renewals.

We plan to present this information for your review and approval at the first Board meeting of each month. I am available at your convenience to discuss this change to Purchasing's reporting process.
