History

We recently contracted American Reading Company to provide curriculum to implement Common Core State Standards in our Kindergarten and 1st grade classrooms, using K-12 Reading funds. As this new curriculum is introduced in these grade levels, many schools throughout the district will want to have consistency in their buildings by providing the same resources to other grade levels.

Description

The curriculum available from American Reading Company includes a unified standard-based framework for student assessment, text leveling, curriculum and instruction. In addition, with classroom libraries and online tools, teachers can conduct formative, standards-based conferences with individual students and track their progress over time.

Action Requested

Approval to allow purchase orders to be processed for American Reading Company in an amount not to exceed \$950,000 for the period of August 20, 2013 through June 30, 2014. Schools and departments will make purchases with funding provided through general, federal, internal, or instructional materials categorical funds.
