RE: **Agreement Amendment – The District School Board of Pasco County and The Red Apple Adult Training Center**

On July 31, 2012, the School District approved the agreement between the District School Board of Pasco County and the Red Apple Adult Training Center pertaining to ESE student J.H. That agreement was recently found to have incorrect dollar figures in the contract. The cover memorandum from ESE was correct. In order to correct the dollar figures, ESE has initiated an amendment. The Exceptional Student Education Department is requesting School Board approval of the attached agreement amendment.

For the months of August 2012 through May 2013, the expenses will not exceed \$1,628.17 per month. For the month of June 2013, the expenses will not exceed \$1,628.19. Expenses will begin on the first day of enrollment of the student. Payment takes approximately thirty days from the receipt of proper invoicing.

Except as specifically amended herein, all terms and conditions of the Agreement shall remain in full force and effect.

Agreement Amendment

The District School Board of Pasco County

The Red Apple Adult Training Center

This Amendment, dated the 16th day of October 2012 by and between The District School Board of Pasco County, Florida, hereinafter referred to as the "District", and The Red Apple Adult Training Center, hereinafter referred to as the "Contracting School".

Whereas, the Contracting School and the District have entered into that certain Agreement dated July 31, 2012; and,

Whereas, the Contracting School and the District desire to amend the terms of the Agreement;

Now, therefore, the Agreement is amended as follows:

The District Agrees To:

2. Voucher the expenses associated with the educational expenses for the District from August 20, 2012 through June 30, 2013. The grand total of expenses for the District will not exceed \$17,909.89. For the months of August 2012 through May 2013, the expenses will not exceed \$1,628.17 per month. For the month of June 2013, the expenses will not exceed \$1,628.19. Expenses will begin on the first day of enrollment of the student. Payment takes approximately thirty days from receipt of proper invoicing.

Except as specifically amended herein, all terms and conditions of the Agreement shall remain in full force and effect.
