On January 19, 2010, official action was taken to award the above-referenced bid to Cargill Kitchen Solutions and renewed for the second year on December 6, 2011 for term dates of July 1, 2012 through June 30, 2013. Current bid language allows new items to be added to the bid by awarded vendors as they become available.

Cargill Kitchen Solutions has submitted pricing for three (3) new products using USDA #100047 (A566) Eggs, Whole Bulk: (1) Breakfast Wrap with Cheese-Club Whole Grain, packed 75/3.1 ounce, (2) Tac-Go with Egg, Cheese, Turkey, Whole Grain, packed 96/3.2 ounce, and (3) Tac-Go with Egg, Cheese, Ham, Whole Grain, packed 96/3.35 ounce. Attached you will find the fee for service price information for the new egg products to be effective through June 30, 2013. Adding these items will allow us to better utilize our USDA Entitlement monies. Pricing on these products is at or below retail prices and found to be competitive.

Estimated annual purchases are not anticipated to change the total bid award of \$230,000, Special Revenue Funds. Julie Hedine, Supervisor, Food and Nutritional Services, requests these products be added to our USDA Commodity Egg Processing bid.

Good Morning Julie,

I wanted to check in with you on 3 new items that Cargill Kitchen Solutions – Sunny Fresh added earlier this year. Items #40275, #40274, #40273 are new Whole Grain items with the same ingredients, size, pack size etc as the already Pasco Commodity Egg Awarded Items #40276, #40277, #40278 except they are made with Whole Grains. Back in May, Roy Pistone (Citrus County) was trying to get these items added to the Power Buying Group Bid (see below e-mails) to be in compliance with the new school regulations of whole grain. I spoke to Dan Copper yesterday and he advised me that these items would have to be additionals to the Pasco Commodity Egg Bid for the Power Buying Group to use since all the eggs for the PBG are currently coming from the Pasco Commodity Egg Bid. Is there any way to get these 3 items added to the Pasco Commodity Egg Bid?

I have attached the specs for all three and the February 2012 updated Cargill Kitchen Solutions SEPDS to show the items are already approved with the USDA. Ken was also going to bring this up to you at the meeting in Denver to see what steps to take next. Thanks so much for your help and I will talk to you soon. Have a safe trip.
