SUBJECT: Request Permission to "Piggy-Back" Hillsborough County Bid P-0201-08(JB) for Cisco Network Equipment, Software and Maintenance Presidio, Inc.

Currently, the Information Services Department purchases Cisco network equipment through a piggy-back of Hillsborough County Bid P-0201-08(JB). This equipment provides local connectivity for services to each school as well as Internet, email and TERMS to each workstation within the school. Our current piggy-back will expire on November 30, 2012.

Under DOE Rule 6A-1.012(6), the Board may make purchases at the unit prices in contracts awarded by other governmental agencies. Presidio Networked Solutions, Inc. (formerly Coleman Technologies) has agreed in writing (attached) to extend the terms and conditions of the Hillsborough County bid to the District. Please see the attached memo from Mr. John Simon, Director of Information Services, and Mr. Chris Jackson, Supervisor of Information Services.

We are requesting permission to piggy-back the Hillsborough County Bid P-0201-08(JB), and to place purchase orders on an as-needed basis not to exceed \$1,250,000.00 for the period December 1, 2012 through August 20, 2013 using budgeted general funds. The Purchasing Department will monitor all Presidio Networked Solutions requisitions to verify that the dollar limits noted above are not exceeded.
